C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The offsite pRPW was not examined during the July 20, 2016 site visit; however, the pRPW is visible in aerial imagery, is depicted as an unnamed blue line feature on USGS topographic maps and has a large drainage area, for these reasons it is likely the pRPW has perennial flow. The offsite pRPW empties into the pRPW Filbin Creek, which empties into the Cooper River, a TNW.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is an approximately 155.41 acre site. The project area is drained by an offsite pRPW that each flow into Filbin Creek which empties into the Cooper River, a TNW. The wetlands total 83.93 acres of waters of the U.S. Wetlands that directly abut pRPWs that empty into TNWs are by definition jurisdictional. Therefore the wetlands were determined to be jurisdictional and subject to regulation under Section 404 of the Clean Water Act.
