Summarize overall biological, chemical and physical functions being performed: **The review area includes the onsite 0.486 acre wetlands, offsite wetlands totaling approximately 208 acres. The review area includes the headwaters of Coosaw Creek. Headwater wetland systems provide a variety of functions that are important for the downstream waters and the watershed as a whole. The wetlands not only provide habitat for various aquatic and terrestrial organisms, including a variety of insects, amphibians, reptiles, mammals and birds, but are also a source of food, nutrients, and carbon for organisms located downstream. The headwater wetlands are especially important for the water quality of a watershed. Water runoff from adjacent uplands that may contain pollutants, sediments, excess nutrients, etc., that flow through the wetlands before entering the tributaries has the opportunity to be filtered out prior to flowing to downstream TNWs. In addition, excess water can temporarily be stored thereby minimizing potential flooding of downstream areas and can also slowly release water downstream to maintain seasonal flow volumes. Runoff water may also transport organisms, nutrients, and carbon from the wetlands into the tributaries, which continue to flow to downstream TNWs.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Coosaw Creek drains directly into the Ashley River, a TNW. There are five monitoring stations along the Ashley River, the closest monitoring station to Coosaw Creek is MD-049, which is downstream of Coosaw Creek, at this point aquatic life uses are not supported due to turbidity and dissolved oxygen excursions. Significant decreasing trends in turbidity, total nitrogen concentration, and fecal coliform bacteria concentration suggest improving conditions for these parameters. Recreational uses are partially supported due to fecal coliform bacteria excursions at this site. The watershed that includes the project review area, HUC 03050201-06, has a high potential for growth. The watershed contains portions of the Towns of Summerville and Ladson and the Cities of Charleston and North Charleston. The area surrounding the project review area is heavily developed and includes both residential and commercial development with the potential for future development to occur in the remaining undeveloped areas. The west bank of the Ashley River contains numerous historic structures including Middleton Place, Drayton Hall, Magnolia Gardens, Runnymede Plantation, and Charles Towne Landing State Park; all are important scenic, cultural, and tourism resources. Areas with a high potential for growth include Amberwood, Jerico on the Ashley, Summerfield, River Oaks, and Shadowmoss in Charleston County; and Coosaw Creek, Whitehall, Avanti Tract, Appian Landing, Bakers Landing, Indigo Fields, and Ricefield/Windsor Hill in Dorchester County. There are water and sewer services available to all these growth areas. When wetlands and streams are filled or altered, many of the services that they provide are compromised and the loss of those services affects downstream TNWs. The wetlands and tributary within the review area have a significant nexus to downstream TNWs as they provide a source of carbon and nutrients, can provide water quality functions, can store excess water minimizing flooding impacts downstream, can maintain seasonal flow volumes, and can transport organisms, carbon, nutrients, sediments, clean water, as well as pollutants, such as those associated with heavy traffic, landscaping chemicals, etc. found within the review area, that may be present or could become present, to downstream TNWs.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is a 3.332 acres site with 0.482 acre of jurisdictional wetlands. Water from Wetland A and Wetland B flow through Jurisdictional Ditch B to an offsite stormwater drainage ditch which flows directly into Coosaw Creek that flows indirectly into the Ashley River, a TNW; therefore the wetlands are subject to regulation under Section 404 of the Clean Water Act.
