



C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area addressed in this form consists of approximately 4.19 acres located at 3719 Sea Mountain Highway in Little River, Horry County, SC. The USGS topographic survey information located within the Wampee quad depicts the project area as upland forest and is void of any blue line features. The project area is comprised of the non-hydric soil Yauhannah and the hydric soil Ogeechee. NWI maps depict the project area as upland planted pine (U42P) and nonforested wetland (PSS4/1B). Due to the consistency in the depiction of uplands throughout the USGS topographic information, NWI maps, soil survey information and aerial photographs, the project was determined to be void of any aquatic resources.
