Creek. The area is expected to receive flood waters from these tributaries. Further, the NWI map appears to show a portion of the review area as PFO1A. Therefore, the entire area, particularly portions mapped as wetland, were reviewed as potential wetland area. The area had evidence of hydrology including water marks on trees immediately outside of the cleared area indicating flooding from nearby tributaries. Some areas within the review area had shallow standing water (1-3 inches) at the time of the site visit. However the soils within the review area were observed to be high chroma, precluding application even of F19 and when taking into account expected disturbance from clearing. Uncleared areas just outside of the review area (on the overall tract but outside of the review area for which this form documents a jurisdictional determination) were found to have high chroma soils as well. Therefore, though the review area does experience significant hydrology including periodic inundation, the 5.7 acre review area was determined to be entirely upland.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
