**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 16.8 acre tract located entirely within uplands adjacent to Cypress Branch. The USGS topographic information within Olanta Quad depicts the project area as a combination of cleared and forested uplands that decrease in elevation to the west as they near Cypress Branch, a solid blue line feature located off-site. NWIs depict the project area as entirely upland agricultural fields. This depiction is supported by aerial photographs and site photos submitted by Pilot Environmental. Florence County LiDAR digital elevation models with 2ft contours and Hill shade reveal that the project area is located entirely within high elevations and that the western project boundary is located along a topographic break with lower elevations located off-site. Aerial photographs depict the project area as upland agricultural fields and Photographs taken on-site and submitted by Pilot Environmental reveal upland agricultural fields bisected by upland excavated drainage ditches. Due to the consistent depiction of uplands in all available desktop resources to this office, the project area was determined to consist entirely of uplands. .
