jurisdictional. The wetlands are predominately located in the central and northern portions of the project area. They consist of concave, depressional gum ponds and are surrounded by upland areas. They receive runoff from these surrounding uplands, but their only outlet is through evapotranspiration. They do not have an apparent surface or subsurface hydrological connection and no apparent ecological interconnectivity with other water features, including any waters of the U.S. The wetlands also have no apparent connection to interstate or foreign commerce. Therefore, the wetlands were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetlands listed in Section I.B.1.b all meet the three parameters of wetland. The wetland features listed in Section I.B.1.b above are part of a larger contiguous wetland system that is directly abutting Fishburne Creek, the perennial tributary described in Section III.D.2. All of the aforementioned wetland features have a contiguous surface water connection to the larger wetland system that also abuts Fishburne Creek. The off-site, named tributary, Fishburne Creek, appears to exhibit perennial flow, as a defined flow channel and bed and bank can be observed from a 2017 Google Earth aerial image. In addition, it appears that this tributary drains an approximately 17 square mile area, obtaining hydrological inputs from surrounding wetlands within the approximate drainage area, as well as from upland runoff also in the drainage area. Fishburne Creek serves as the headwater system for Rantowles Creek, a TNW. Fishburne Creek appears to flow approximately for 8 miles, where it joins with an unnamed tributary and forms Rantowles Creek. At this junction, Rantowles Creek flows for approximately 2 miles and exhibits characteristics of a perennial RPW. As Rantowles Creek continues towards the southeast, it obtains tidal influence near U.S. Hwy 17, and would be considered a TNW. Therefore, it was determined that the wetlands listed above in Section I.B.1.b are jurisdictional under Section 404 of the CWA.
