The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Summarize overall biological, chemical and physical functions being performed: **The wetlands evaluated in this SND are performing biological, chemical, and physical functions that relate to the integrity of the downstream TNW. Wetland A flows south to offsite perennial RPW through an open top pipe after heavy rain events, and during wetter months as seen in the topo map. Wetland B flows to the offsite perennial RPW through a metal pipe during heavy rains and wetter months. Wetland C is directly abutting the offsite perennial RPW. A variety of biological functions are being performed by the wetlands. The wetlands provide possible breeding grounds for aquatic species as well as habitat for wildlife in the area. The chemical functions include nutrient and waste filtration for the surrounding urban and agricultural areas. The physical functions of the wetlands include flow maintenance by retaining runoff and storm water during times of heavy rain and during the wetter months.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
