jurisdictional. These wetland areas are identified as Wetland B=1.16 acres, Wetland C=8.19 acres, Wetland D=0.89 acres, Wetland E=1.84 acres, Wetland F=0.64 acres, and Wetland G=0.27 acres. They consist of concave, depressional gum ponds surrounded by upland areas. These features likely accept stormwater runoff from the surrounding upland areas, but their only outlet is through evapotranspiration. They do not have any surface or apparent subsurface hydrological connection and no apparent ecological interconnectivity with other water features, including any waters of the US and no apparent connection to interstate or foreign commerce. Therefore, these wetlands were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA. In addition, a linear conveyance feature was identified within the property. This feature was determined to be non-jurisdictional linear conveyances, as it did not convey an Ordinary High Water Mark, bed and bank, nor flow characteristics. The linear conveyance conveyed only surface water runoff from the surrounding uplands, and had no visible evidence of relatively permanent flow. In addition, the conveyance drained only uplands. For this reasons, the linear conveyance was determined to be non-jurisdictional and not regulated by Section 404 of the CWA..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These wetland areas are identified as Wetland B=1.16 acres, Wetland C=8.19 acres, Wetland D=0.89 acres, Wetland E=1.84 acres, Wetland F=0.64 acres, and Wetland G=0.27 acres. They consist of concave, depressional gum ponds surrounded by upland areas. These features likely accept stormwater runoff from the surrounding upland areas, but their only outlet is through evapotranspiration. They do not have any surface or apparent subsurface hydrological connection and no apparent ecological interconnectivity with other water features, including any waters of the US and no apparent connection to interstate or foreign commerce. Therefore, these wetlands were determined to be non-jurisdictional and not subject to regulation under Section 404 of the CWA. In addition, a linear conveyance feature was identified within the property. This feature was determined to be non-jurisdictional linear conveyances, as it did not convey an Ordinary High Water Mark, bed and bank, nor flow characteristics. The linear conveyance conveyed only surface water runoff from the surrounding uplands, and had no visible evidence of relatively permanent flow. In addition, the conveyance drained only uplands. For this reasons, the linear conveyance was determined to be non-jurisdictional and not regulated by Section 404 of the CWA.

Therefore, it was determined that Wetland A is jurisdictional under Section 404 of the CWA.
