hydrophytic vegetation growing, but there is no evidence of hydrology in the area. The Corps' site visit was conducted

in the rain and no evidence was observed. The hydrophytic vegetation is likely due to the area being the low spot on the site and water pooling there occasionally. This area appears to be an old drainage ditch that was not maintained. There is a drainage feature above it (off-site) and below it. The non-jurisdictional drainage feature below the low area, close to the road, had no signs of relatively permanent flow and no OHWM. The low area and the drainage area were separated by an area that is higher in elevation than both features.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal tributary performs a variety of functions related to the biological, chemical, and physical integrity of the downstream TNW. The biological characteristics include providing breeding grounds and shelter for aquatic species and providing habitat for wildlife in the area. The chemical characteristics include filtering excess nutrients contributed by runoff from surrounding lands. The physical characteristics include performing flow maintenance functions such as storing water during heavy rains and wetter months and retaining runoff from adjacent lands. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the TNW, it has been determined there is a significant nexus between the relevant reach of the tributary to the downstream TNW.
