C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form assesses a 2.0 acre site that consists entirely of uplands. An office determination was conducted for this site. After researching the best available information (i.e. aerial photographs, topographic maps, soil survey information, and NWI maps) it was determined that aquatic resources do not exist on the property. No saturation or inundation can be observed on aerial photographs. Topographic maps do not depict any wetlands or tributaries within the project boundary. NWI maps depict the site as uplands. In addition, soil survey maps depict a Blanton soil series (non-hydric) throughout the entire site. The applicant also submitted photos of non-hydric soils within the site and data sheets that depict the site has having no hydrology or hydrophitic vegetation. Therefore, the Corps has determined that the site consists entirely of uplands.
