Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. These wetland areas share a direct hydrological connection with the TNW. When the TNW overflows, water can flow directly to the wetlands and surface water from the wetlands can also drain directly into the TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

the Ashley River onsite. This RPW consists of a straight channel with water depth between 3-4 feet and channel depth between 6-12 feet. This unnamed tributary was flowing at the time of survey. This tributary exhibits physical and hydrological characteristics commonly associated perennial flow including discernible bank and streambed. The tributary is a primary drainage for the project site, as well as a large neighborhood off of Paramount Drive, including portions that may be considered wetlands. Numerous drainage features flow into this tributary from adjacent neighborhoods.

ADDITIONAL COMMENTS TO SUPPORT JD: This 79.256 Acre site contains 0.304 acres of Traditional Navigable Water subject to Corps regulatory authority under Clean Water Act Section 404 and Section 10 of the Rivers and Harbors Act. The site also contains 4.991 acres of freshwater wetlands and 0.869 acres of jurisdictional pRPW subject to Corps regulatory authority under Clean Water Act Section 404. Ashley River is a TNW subject to the ebb and flow of the tide and a Section 10 water.
