Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: One non-jurisdictional linear conveyance is located onsite. The Linear Conveyance runs along the north side of the project area and goes underneath a gravel road. It terminates in Jurisdictional Wetland "A". The linear feature is heavily vegetated in the channel. The sloped banks on either side of the conveyance and the straight channel is indicative of a dug channel for wet weather conveyance. The conveyance is not seen on topographic maps. Additionally, the feature does not display the characteristics of a tributary such as ordinary high water mark. This feature is surrounded by uplands on-site and appears dug in uplands. This feature therefore is non-jurisdictional and not subject to regulation under section 404 of the Clean Water Act. This feature is shown on the survey plat and supplemental sketch.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
