### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area is comprised of 42.8 acres of uplands east of and adjacent to SC Highway 9 in Little River, SC. The project area contains six (6) non-jurisdictional ditches that were excavated out of uplands and drain only uplands and two (2) upland excavated ponds not considered impoundments of water of the United States. USGS topographic survey information within the Longs quad depicts open water bodies that were determined to be upland excavated ponds. The project area is comprised of the hydric soil Ogeechee and the partially hydric soil Eulonia. NWI maps depict upland planted pine (U42P) and forested wetlands (PFO4B). Based on a combination of the above listed resources and previous determinations, the project area was determined to be void of any aquatic resources. The project area has two previous upland calls documented in SAC 2000-30737-3JH, letters dated 2/20/2008 & 6/25/2012. . .
