**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 120.97 acres. Of which, only 46.59 acres were evaluated for the presence or absence of the Waters of the United States. This is due to a previously issued Department of the Army permit (SAC 2005-3W-381) that required the remaining wetlands not impacted by the permitted project to be buffered and preserved. In the project area of Tract B, there are 74.38 acres of “protected area” that were placed in restrictive covenants and were not evaluated under this determination. The remaining areas that were evaluated contains 3.63 acres of freshwater wetlands and 42.96 acres uplands. Wetlands identified during the July 2017, Site visits were determined to be directly abutting an offsite tributary that flows directly into the Waccamaw River. One potential wetland area (0.31 acres) was evaluated but was determined to lack hydrology and hydric soils (more than 30% uncoated sand grains).**
