- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Four wetlands [Wetland 4 (0.85 ac.) + Wetland 5 (0.82 ac.) + Wetland 6 (0.34 ac.) + Wetland 7 (0.85 ac.) = 2.86 acres] in the review area were observed in the field and determined to be isolated (non-jurisdictional). The entire perimeter of all four wetlands was observed in the field and was determined that all four wetlands are completely surrounded by non-hydric soils. Therefore, no surface or shallow subsurface connection, from the wetlands to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within these wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. Topographic maps do not depict any wetland symbols or tributaries (i.e. blue lines) within close proximity to the subject wetland. There is a series of man-made non-jurisdictional ditches that traverse the property. However, the ditches do not intersect any of the isolated wetlands. The onsite wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Four wetlands [Wetland 4 (0.85 ac.) + Wetland 5 (0.82 ac.) + Wetland 6 (0.34 ac.) + Wetland 7 (0.85 ac.) = 2.86] in the review area were observed in the field and determined to be isolated (non-jurisdictional). The entire perimeter of all four wetlands was observed in the field and it was determined that all four wetlands are completely surrounded by non-hydric soils. Therefore, no surface or shallow subsurface connection, from the wetlands to another waters of the U.S. was evident during the site visit or could be found after a review of aerial photography, soil survey information, NWI maps, and topographic maps. All water contained within these wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. Topographic maps do not depict any wetland symbols or tributaries (i.e. blue lines) within close proximity to the subject wetland. There is a series of man-made non-jurisdictional ditches that traverse the property. However, the ditches do not intersect any of the isolated wetlands. The onsite wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.**

B. **ADDITIONAL COMMENTS TO SUPPORT JD: Three wetlands (Wetlands 1,2, and 3) were assessed onsite and determined to be jurisdictional. The three wetlands are adjacent to a TNW (Six Mile Creek). Wetland 1 is a portion of a larger linear wetland system that flows offsite to the north until it intersects Six Mile Creek. Wetlands 2 and 3 directly abut a non-jurisdictional roadside ditch along Browns Ferry Road which flows to the north directly into Six Mile Creek located approximately 0.75 miles from the site. According to USACE Navigability Study Report No. 6, the upstream tidal influence of the Black River is approximated at River Mile**

**(RM) 40. Six Mile creek is a major tributary to the Black River located downstream of RM 40 and is therefore influenced by the ebb and flow of the tide. Therefore, Six Mile Creek was determined to be a TNW.**
