**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The proposed project area consist of a 6' wide path originating east of Seaside Drive and terminating shoreward of the High Tide Line. A site visit conducted on 6/20/17 revealed that the area in question was significantly higher in elevation than surrounding wetland areas. Soils within the proposed project area were determined to lack Hydric Soils indicators and indicators of hydrology and therefore do not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland. A review of historic aerial photograph reveals several sandy upland paths bisecting the vegetated area between Seaside Drive and the beach in the vicinity of the project area. Based on the information above, the 0.017 acre project area was determined to consist entirely of dry land..
