B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). 2. Summarize overall biological, chemical and physical functions being performed: **Biological- The wetlands adjacent to and/or abutting the tributary are characterized by mixed hardwood forest that has been impacted by prior forestry activities. These wetlands provide a wide array of biological functions which include providing breeding grounds and shelter for aquatic species and foraging areas for wetland dependent species. These wetlands are essential in providing organic carbon in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. The wetlands within the review area are located near the Town of Summerville, which is a heavily developed area and is continuing to expand at a rapid rate. Chemical- The wetland performs important functions to filter pollutants and sediments caused by traffic and development, preventing them from entering Platt Branch and the Ashley River. Physical: These wetlands also provide for flood storage in heavy rain events along with habitat for a diverse group of aquatic and upland species. According to the SCDHEC Watershed website, The Ashley River has been shown to exhibit high turbidity due to elevated suspended sediments and other particulates, have lowered dissolved oxygen levels and heightened biological oxygen demand (BOD). The influx of relatively better water quality with respect to these measures demonstrates the important contribution of lower turbidity and higher oxygen level waters that are made by the relevant reach and its collective abutting and adjacent wetlands to the integrity of the downstream TNW.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The influx of relatively better water quality with respect to these measures demonstrates the important contribution of lower turbidity and higher oxygen level waters that are made by the relevant reach and its collective abutting and adjacent wetlands to the integrity of the downstream TNW. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditionally navigable waters of the Ashley River, this office has determined that there is a significant nexus between the review area relevant reach and its adjacent wetlands and the downstream TNW.

directly abutting an RPW: **Jurisdictional Wetlands 2 and 3 have a direct surface water connection to the Jurisdictional Tributary/Platt Branch. Both Wetlands 2 and 3 are part of a larger, contiguous wetland system onsite. However, these wetland areas are preserved as mitigation for a previous DA permit (SAC-26-95-0111X) and therefore were not included in this JD. Lastly, the Jurisdictional Tributary flows through these preserved wetland areas, where it intercepts surface water flow from these wetlands, as well as Wetlands 2 and 3. Due to the direct surface water connection, Wetlands 2 and 3 are considered abutting the tributary and are considered jurisdictional.**
