C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This unnamed tributary appears to exhibit perennial flow characteristics, as it is a mapped USGS blue line stream, and a OHWM and bed and bank can be observed on Google Earth Aerial Imagery. The unnamed perennial tributary flows northeast and discharges into the Santee River, a TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Jurisdictional Wetland A is part of a larger contiguous wetland system that continues offsite. This wetland system continues north towards the unnamed perennial tributary, where it has a contiguous surface water connection with the tributary feature. For this reason, Jurisdictional Wetland A is considered to be abutting the RPW and therefore subject to regulation under Section 404 of the CWA.
