**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses an 8.76 acre tract that was determined to contain 1.26 acres of jurisdictional wetlands and 475 linear feet of jurisdictional pRPW. Indicators of hydrology on site during a site visit conducted on 2/9/18 included inundation, saturation, water stained leaves and sphagnum moss. Soils within the delineated wetland met a S7 hydric soils indicator. The pRPW located within the wetland had a firm sandy bottom, continuous OHWM and channel washed clear of vegetation and debris. Flowing water was observed on site during the site visit. In addition to abutting the pRPW, the wetland onsite is part of a larger contiguous wetland system that continues offsite to the west and abuts the Waccamaw River. Based on a review of available desktop resources; including aerial photographs, NWIs and USGS topographic survey information, there are no natural or man-made barriers that would disrupt the physical, chemical, and/or biological connection between the onsite wetland and the TNW .

On June 8, 2018, the agent submitted a revised plat that depicts the additional wetlands observed on the site visit dated February 9, 2018.
