C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The Great Pee Dee River is a major river system. According to the USACE Navigability Study Report No. 11, the Great Pee Dee River's recommended limit of navigability is located at River Mile (RM) 188.2. The project waters enter the Great Pee Dee River downstream of RM 90 which is located downstream of the recommended limit of navigability.

Twomile creek is shown on USGS topographic map to be under 100 meters from the property line with apparent wetland vegetation shown on aerial imagery. A site visit (June 20, 2018) verified the presence of wetlands located in the northeast and northwest corners, as well as the wetlands' immediately adjacent to Twomile Creek (pRPW). The Corps determined the wetland continues contiguously in a northward direction off-site until it intersects the OHWM of Twomile Creek. Within the 10.18 acre Palmetto Corp Tract the Corps identified 0.002 acres of onsite jurisdictional aquatic resources (wetlands), subject to 404 CWA, all on the northward property boundary that are a portion of a larger contiguous fully-functioning wetland system.
