C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Tributaries of TNW where tributaries have continuous flow “seasonally” (e.g., typically three months each year) are jurisdictional. Data supporting this conclusion is provided at Section III.B. Provide rationale indicating that tributary flows seasonally: **A review of aerial imagery, LIDAR, and topographic maps was conducted to assess the location and characteristics of the unnamed tributary of Buck Creek, a feature which runs generally east-west along the southern boundary of the project property. This unnamed tributary is depicted on USGS topographic maps as a water feature that is annotated as a solid blue line, an indicator of perennial flow. LIDAR imagery clearly shows the linear tributary just south of the site. Additionally, LIDAR depicts a region of depressed elevation boarding the property's southeastern border and the offsite adjacent neighborhood "The Park at Long Bay." This depressional feature serves as a connection point from the contiguous wetlands, which originate on the project site and continue to the OHWM of the tributary. Aerial imagery from 2006 shows a dark linear feature located immediately south of the property, which correlates directly with the blue line feature seen on USGS topographic maps and the depressed linear feature seen on LIDAR. Furthermore, a densely forested area can be seen to the north of "The Park at Long Bay" in the same approximate area that the LIDAR imagery depicts as a depression that is eventually bisected by the OHWM of the unnamed tributary.**

The hydrologic flow from the on-site wetlands have two connections to the unnamed tributary: primarily, through perennial flow to the north and east through a contiguous wetland feature that continues offsite and eventually abuts the OHWM offsite unnamed tributary located in the northern extent of neighborhood "The Park at Long Bay", and secondarily, through seasonal flow to the south via a non-jurisdictional ditch excavated through uplands that discharges directly into the unnamed tributary.**

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This form addressed a 26.82 acre tract that contains 2.94 acres of jurisdictional freshwater wetlands subject to the jurisdiction of this office. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. A review of aerial imagery, LIDAR, and topographic maps was conducted to assess the location and characteristics of the unnamed tributary of Buck Creek, a feature which runs generally east-west along the southern boundary of the project property. This unnamed tributary is depicted on USGS topographic maps as a water feature that is annotated as a solid blue line, an indicator of perennial flow. LIDAR imagery clearly shows the linear tributary just south of the site. Additionally, LIDAR depicts a region of depressed elevation boarding the property's southeastern border and the neighborhood "The Park at Long Bay." This depressional feature serves as a connection point from the contiguous wetlands, which originate on the project site and continue to the OHWM of the tributary. Aerial imagery from 2006 shows a dark linear feature located immediately south of the property, which correlates directly with the blue line feature seen on USGS topographic maps and the depressed linear feature seen on LIDAR. Furthermore, a densely forested area can be seen to the north of "The Park at Long Bay" in the same approximate area that the LIDAR imagery depicts as a depression that is eventually bisected by the OHWM of the unnamed tributary.

The on-site wetlands are a component of a larger contiguous wetland feature that continue offsite and directly abut the ordinary high water mark (OHWM) of an unnamed tributary (pRPW) of Buck Creek. The hydrologic flow from the on-site wetlands have two connections to the unnamed tributary: primarily, through perennial flow to the north and east through a contiguous wetland feature that continues offsite and eventually abuts the OHWM offsite unnamed tributary located in the northern extent of neighborhood "The Park at Long Bay", and secondarily, through seasonal flow to the south via a non-jurisdictional ditch excavated through uplands that discharges directly into the unnamed tributary.

Longs Quad, depicts a forested area with asloping elevation on the southern boundary of the property leading to a solid blue line water feature, a jurisdictional non-named tributary of Buck Creek that runs east-west just south of the project property line. The tributary continues east, under Highway 9, and while broken at the surface, maintains a hydrological connection with perennial flow underground, discharging directly into Buck Creek on the east side of Highway 9; this feature is depicted as an unbroken blue line on the quad imagery
