C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. Big Cedar Branch runs generally in an east-west direction to the north of the project property, and receives flow from a large wetland system that begins on the project site and wraps north-northeastward to Big Cedar Branch. Big Cedar Branch is depicted on USGS topographic maps as a water feature that is annotated as a solid blue line, an indicator of perennial flow.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addressed a 41.25 acre tract that contains 10.03 acres of jurisdictional freshwater wetlands subject to the jurisdiction of this office. Limits of jurisdiction were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Hydric soils, hydrophytic vegetation, and hydrology was observed in the field during the site audit in the wetland areas. Soils observed in the wetland area contained high levels of organic materials in the predominately loamy soils. The uplands areas were distinct by their sandy soil with greater than 30% uncoated sand grains. Additionally, the on-site wetlands are a component of a larger contiguous wetland feature that continue offsite and eventually are bisected by the ordinary high water mark (OHWM) of the Big Cedar Branch tributary (pRPW), a perennial RPW that discharges directly into Buck Creek. A review of aerial imagery, LiDAR, and topographic maps was conducted to assess the location and characteristics of Big Cedar Branch, a tributary of Buck Creek (pRPW). Big Cedar Branch runs generally in an east-west direction to the north of the project property, and receives flow from a large wetland system that begins on the project site and wraps north-northeastward to Big Cedar Branch. Big Cedar Branch is depicted on USGS topographic maps as a water feature that is annotated as a solid blue line, an indicator of perennial flow. The on-site wetlands are annotated on USGS topographic maps as a labeled wetland feature encircled by a contour line to indicate a depressional lower-elevation region that runs generally from the project site directly to the tributary. Aerial imagery from 2006 shows what appears to be mixed evergreen needle-leaved and deciduous broad-leaved hardwood wetlands in a contiguous swath from the western portion of the project site to an area adjacent to Big Cedar Branch tributary. On aerial imagery the mixed hardwood-pine wetlands appear to stop at what appears to be an industrial pine plantation approximately 160 meters from the tributary, however there are multiple low elevation areas, including forestry roads with man-made ditches indicated on LiDAR and aerial imagery, which would serve to convey water from the wetlands to the tributary. The wetlands are additionally connected through seasonal flow to through man-made ditches that encircle the adjacent neighborhood to the north and directly drain into Big Cedar Branch. Hammond Quad depicts an area of labeled wetlands encircled by a contour line within the western edge of the project location and to the adjacent west-northwest outside of the project area. The labeled wetlands and lower-elevation region continue northwards and abut a blue line water feature labeled as Big Cedar Branch, a perennial RPW of Buck Creek

To the north of the project site and abutting the wetland region, LiDAR imagery clearly shows a diffuse tributary system comprising the Big Cedar Branch, this tributary also serves as a northward boundary for the development of the adjacent neighborhood to the north of the project site. LiDAR depicts the Big Cedar Branch tributary leading east directly into Buck Creek, thus this water feature serves as a connection point from the on-site wetlands to the OHWM of the tributary. Additionally, LiDAR indicates the presence of a man-made excavated drainage system encircling the south, east, and western boundaries of the adjacent neighborhood to the north of the project site, this drainage system leads directly to the Big Cedar Branch tributary (comprising the northern boundary of the neighborhood) and would receive sheet-flow from the on-site wetlands during periods of seasonal heavy rainfall.

Located on-site are three upland excavated non-jurisdictional features, including two ditches that lacks the characteristics of a tributary and one pond that lacks any outflow or hydrologic linkages to jurisdictional features; both of these non-jurisdictional waters convey surface and stormwater only.

This site was assessed on a single basis form.
