**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 1.87 acre site that contains 0.82 acres preserved under Department of Army Permit #2000-1P-466 and that are not a part of this determination. The remaining 1.05 acres of the tract were determined to consist entirely of uplands. This portion of the tract was previously determined to be uplands in Approved Jurisdictional Determination 81-98-0866, issued on 8/12/98. Subsequently development occurred in and adjacent to the project area under Department of the Army Permit #2000-1P-466. Based on aerial photographs the portion of this tract under review is currently a maintained upland grassy field. Site photos and data sheets submitted by the consultant depict soils that do not meet a hydric soils indicator and state that no indicators of hydrology were observed on-site.
