and/or do not display an OHWM. Some of the non-jurisdictional ditches provide hydrologic conveyances for Wetlands 1, 2 and 3 to the offsite TNW. The project area also contains three non-jurisdictional ponds upland excavated from within uplands documented in previous determination 82-2002-0002 and SAC 2012-01170.

Wetlands 1 & 2 are adjacent to non-jurisdictional hydrologic conveyances (ditches) that drain offsite and discharge into an offsite stormwater system that discharges into the AIWW. Wetland 3 discharges into an offsite stormwater system that discharges into the AIWW/TNW. Wetland 2 historically was part of Folly Swamp that discharged into the AIWW. Over the years this system has been manipulated where the ruin has been altered by piping and re-routing and today appears to be part of the adjacent stormwater system. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site is comprised of 542.07 acres of undeveloped land. Within the 542.07 acre project area, the site contains 34.67 acres of freshwater wetlands and 1,335 linear feet of onsite tributary (documented on basis form 2 of 2). The site has been manipulated over the years with the installation of 10' wide typical ditching throughout. Potential wetlands were assessed, but determined to lack hydrology and/or any indicators of hydrology. The site is surrounded by residential and minor commercial development.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site is comprised of 542.07 acres of undeveloped land. Within the 542.07 acre project area, the site contains 39.31 acres of freshwater wetlands and 1,945 linear feet of onsite tributary.
