EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The site is comprised of 0.13 acres of dry land / existing homesite for years. LiDAR imagery indicates potential WOUS located north of the site, but the site was determined to be dry land based on the site photos included in the original submittal.
