**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A solid blue line on the USGS topographic map is the symbol for water with flow at least 90% of the year. Sumter county soil survey information depicts soil in this area as 100% hydric. Aerial photographs depict a shaded linear feature which typically represents a waters of the U.S. This feature was first identified in Preliminary JD (SAC 2014-00899) issued on January 26, 2015 with associated site visit conducted on November 12, 2014. The RPW was documented as having flow on August 5, 2015 (below average rainfall) and on April 23, 2016 (above average rainfall).

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form address a 27.24 acre site that was determined to contain 1395.05 linear feet of a perennial relatively permanent water. This feature was first identified under drought conditions in Preliminary JD (SAC 2014-00899) issued on January 26, 2015 with a site visit was conducted on November 12, 2014. The RPW was documented as having flow on August 5, 2015 (below average rainfall) and on April 23, 2016 (above average rainfall). The tributary is depicted on USGS topographic survey maps as a named solid blue line that flows unobstructed into Shot Pouch Branch which flows into Green Swamp which empties into the Pocatigo River, which flows into to the black river at R.M. 107.7. A solid blue line on the USGS topographic map is the symbol for water with flow at least 90% of the year. Sumter county soil survey information depicts soil in this area as 100% hydric. Aerial photographs depict a shaded linear feature which typically represents a waters of the U.S. Sumter County LiDAR overlay with Hillshade depicts the pRPW as a sinuous feature with a defined channel that flows uninterrupted into Shot Pouch Branch. One non-jurisdictional ditch is located on site. This feature is depicted on the USGS topo map as a solid blue line feature bisecting the southern project boundary. This feature was determined to have been excavated out of uplands for the purpose of draining uplands. This feature was documented as being void of flow indicators and/or and OHWM during a site visit conducted by the Corps on 11/12/14.
