- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Potential wetlands on-site were examined during a site visit conducted on 5/11/16 and determined to lack indicators of hydrology during a period of above average rainfall and therefore do not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland.**

On the USGS topographic map one dashed blue line feature is depicted bisecting the northeast project corner and running along the eastern project boundary and one open water feature is depicted near the center of the site. These features were examined during a site visit conducted on 5/11/16 and determined to be man-made, excavated out of uplands, and to drain only uplands. Four additional man-made drainage ditches, excavated out of uplands and draining only uplands, are located on-site. Two ditches extend from the southern project boundary towards the center of the site. These ditches are located on either side of a relic airplane run way. The remaining two ditches run west to east bisecting the project area. These features were determined to be non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: **This form addresses a 111.35 acre lot located in Marlboro County that was determined to consist entirely of uplands. A site visit conducted on 5/11/16 revealed that this site did not contain any indicators of hydrology during a period of above average rainfall. During the site visit several soil samples were taken, most of which were concentrated in low lying areas identified using LiDAR overlays. Soils on site were similar to Coxville and met an A11 indicator of Hydric Soils, however no primary and/or secondary indicators of hydrology were observed anywhere on site. Based on NRCS Wets data Marlboro County was in a period of above average rainfall and several large ditches bisected the property, therefore hydrology was not assumed. These ditches (including the dashed blue line observed on USGS topo Maps) appeared to be man-made and excavated out of what was determined to be uplands. The open water feature depicted on USGS topo maps was determined to be a non-jurisdictional upland excavated pond. The site was determined to be void of Aquatic Resources.**
