- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

Six non-jurisdictional isolated wetland are located on the subject property:

Non-Jurisdictional Isolated Wetland A is located within the southeastern section of the property and is a 0.15± acre portion of a larger isolated wetland. This is a depressional forested palustrine wetland and is dominated by *Nyssa biflora*, *Acer rubrum* and *Liquidambar styraciflua*. This wetland is surrounded by uplands that include residential development on one side and an existing road on the other side. The surrounding uplands are approximately 2-3 feet higher in elevation. This wetland does not appear to make any on-site or off site hydrological connections that would support adjacency.

Non-Jurisdictional Isolated Wetland B located within the eastern section of the property and is a 0.47± acre portion of a larger isolated wetland. This is a depressional forested palustrine wetland and is dominated by *Nyssa biflora*, *Acer rubrum* and *Liquidambar styraciflua*. This wetland is surrounded by uplands that include residential development on one side and an existing road on the other side. The surrounding uplands are approximately 2-3 feet higher in elevation. Non-Jurisdictional Swale E connects to this wetland from the north; however, non-jurisdictional Swale E does not connect to any other jurisdictional features. This wetland does not make any on-site or off site hydrological connections that would support adjacency.

Non-Jurisdictional Isolated Wetland C is located within the northwestern section of the property and is a 0.04± acre portion of a larger isolated wetland. This is a depressional forested palustrine wetland and is dominated by *Nyssa biflora*, *Acer rubrum* and *Liquidambar styraciflua*. This wetland is surrounded by uplands that include residential development and upland ridges which are approximately 1-2 feet higher in elevation. This wetland connects to an off-site ditch, but this ditch appears to be upland-cut and does not appear to make any off-site hydrological connections that would support adjacency.

Non-Jurisdictional Isolated Wetland D is located entirely within the northwestern section of the property and totals 0.06± acre. This is a depressional forested palustrine wetland and is dominated by *Nyssa biflora*, *Acer rubrum* and *Liquidambar styraciflua*. This wetland is surrounded by upland ridges which are approximately 2-4 feet higher in elevation. Non-Jurisdictional Swale B connects to this wetland from the south and continues off-site to the north; however, this swale is upland-cut and does not connect to any jurisdictional features. Non-Jurisdictional Swale A connects to Non-Jurisdictional Swale B, but does not connect to any other wetlands or jurisdictional features. This wetland does not make any on-site hydrological connections that would support adjacency.

Non-Jurisdictional Isolated Wetland E is located entirely within the northwestern section of the property and totals 0.80± acre. This is a depressional forested palustrine wetland and is dominated by *Nyssa biflora*, *Acer rubrum* and *Liquidambar styraciflua*. This wetland is surrounded by upland habitat which ranges between 2 and 6 feet higher in elevation. Non-Jurisdictional Swale C connects to this wetland from the south. However, this swale is upland-cut and does not connect to any jurisdictional features. This wetland does not make any on-site hydrological connections that would support adjacency.

Non-Jurisdictional Isolated Wetland F is located entirely within the northwestern section of the property and totals 0.23± acre. This is a depressional forested palustrine wetland and is dominated by *Nyssa biflora*, *Acer rubrum* and *Liquidambar styraciflua*. This wetland is surrounded by upland habitat which ranges between 2 to 4 feet higher in elevation. This wetland does not make any on-site hydrological connections that would support adjacency.

In all of these wetlands, there is a clear elevation change from the upland to the wetland. There was no apparent surface or shallow subsurface hydrologic connection, no apparent connection to interstate or foreign commerce and no apparent evidence of ecological interconnectivity between these isolated wetlands and jurisdictional waters of the U.S. Therefore these wetlands were determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.

Five non-jurisdictional swales are located on the property:

Non-jurisdictional swales A-E are located in the northern and central portions of the property. These swales are all upland cut and drain only upland areas. These features were examined in the field. These swales did not exhibit signs of flow or an OHWM. No connections to jurisdictional features were observed in the field on the day of the site visit, 2/17/2016. In addition, by definition, swales are not considered waters of the U. S.

Non-Jurisdictional Swale A connects to Non-Jurisdictional Swale B, but does not connect to any other wetlands or jurisdictional features.

Non-Jurisdictional Swale B connects to Non-Jurisdictional Isolated Wetland D from the south and continues off-site to the north; however, this swale is upland-cut and does not connect to any jurisdictional features.

Non-Jurisdictional Swale C connects to Non-Jurisdictional Isolated Wetland E from the south. However, this swale is upland-cut and does not connect to any jurisdictional features.

Non-Jurisdictional Swale D is located in the central portion of the site and is entirely upland-cut. This swale does not connect to any jurisdictional features.

Non-Jurisdictional Swale E connects to Non-Jurisdictional Isolated Wetland B from the north; however, non-jurisdictional Swale E does not connect to any jurisdictional features.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
