due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delimitation Manual and the 2010 Coastal Plain Supplement, a site visit conducted on 4/11/16 revealed that the wetland onsite is completely encompassed by soils that do not meet the hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface of subsurface hydrologic connection is inhibited .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Cite scale & quad name: **Timmonsville Quad; USGS topographic survey information within Timmonsville quad depicts the project area as uplands bisected by 3 solid blue line features located within naturally lowlying drainage areas. A site visit conducted on 4/11/16 revealed that these blue line features and low lying drainage areas do not exist within the boundaries of the project area. These features are shelter belts/hedge rows consisting of mature terrestrial vegetation. These features do not encompass any drainage features such as ditches or swales. Soils at these locations did not meet any hydric soil criteria.**
- USDA Natural Resources Conservation Service Soil Survey. Citation: **Florence County Soil Sheet # 15; Florence County Soil Survey information depicts the project area as being comprised of the following soil types: Lynchburg, Goldsboro and Coxville. Lynchburg is described as a somewhat poorly drained partially hydric soil. Coxville is described as a poorly drained all hydric sandy loam. Goldsboro is described as moderately well drained partially hydric loamy sand. The delineated wetland on-site is mapped coxville. A portion of the uplands on site are also mapped coxville however soil samples taken during a site visit on 4/11/16 revealed that soils at this location where high chroma and value and did not meet any hydric soil indicators.**

drained. Wetlands are depicted along the northwest project boundary, bisecting the center of the property and protruding into the property along the southwest property boundary in the vicinity of the delineated wetland. NWIs depict the wetlands as continuing off site to the west however approved jurisdictional determination SAC 2007-02239 reveals that the wetlands do not continue off site to the west. The portions of the property mapped wet located to the northwest and the center of the property were assessed during a site visit on 4/11/16 and did not meet the criteria set forth in the 1987 delineation manual. Specifically they did not meet the hydric soil criteria and did not contain any indicators of hydrology. The wetland depicted on the southwest property boundary was determined to be confined within the project boundary.

Aerial photographs also depict the project area as combination of agricultural uplands and commercial development bisected by 3 wooded linear features. A site visit conducted on 4/11/16 revealed that these features are shelter belts/hedge rows consisting of mature terrestrial vegetation. These features do not encompass any drainage features such as ditches or swales. Soils at these locations did not meet any hydric soil criteria.

- Other information (please specify): Approved Jurisdictional Determination SAC 2007-02239 depicts uplands on the adjacent property to the west of the project area that is the subject of this form and no tributaries. Two isolated wetlands are located on the adjacent property however they are not located near the property boundary separating the adjacent property from the property that is the subject of this form. The property boundary between the two sites is depicted entirely as uplands.

Sumter County LiDAR overlay reveals a depressional feature in the location of the delineated wetland and does not depict any features that would typically represent a tributary or drainage feature within the limits of the project boundary.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 18.25 acre tract that was determined to consist of approximately 17.84 acres of uplands and a 0.41 acre of wetland that was determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, a site visit conducted on 4/11/16 revealed that the wetland onsite is completely encompassed by soils that do not meet the hydric soil or hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface of subsurface hydrologic connection is inhibited. During the site visit the entire perimeter of the wetland was examined. There were no culverts or drainage features (e.g., ditches or swales) located in the vicinity of the wetland. The wetland is a depressional feature that was determined to be bordered on all sides by uplands that are disrupting any possible chemical, physical, or biological connection to a downstream TNW.
