**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 3 acre tract that is determined to consist entirely of uplands. The project area currently consist of a combination of forested uplands, an existing pump station, and an existing football field. The project area is located in the down town area of Andrews, SC. The USGS topographic survey information located within the Andrews Quad depicts the project area as uplands bisected by a solid purple line. This feature is the symbol for a tributary with perennial flow. Purple is used to depict a revision on the map. Based on site photos submitted by the agent that reveal terrestrial vegetation growing in the bottom of this feature, its location within uplands / draining only uplands, and its depiction as a non-sinuuous feature added as a revision to the map (suggesting that it is man-made feature) , this feature was determined to be non-jurisdictional. The National Wetlands inventory has mapped the project area as forested uplands and residential uplands. Georgetown County soil survey information depicts the project area as being comprised of partially hydric soils with a very low percentage of hydric inclusions. Aerial photographs show that the project area consists of developed land that does not contain any features that would indicate the presence of a water of the United States. A data point taken within the forested portion of the site revealed non-hydric soils on-site and a lack of indicators of hydrology. Due to the consistent upland depiction seen throughout USGS topographic survey information, Georgetown County soil surveys, the NWI, the data sheet and aerial photographs, the project area has been determined to consist entirely of uplands.
