### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area is comprised of 13.82 acres of undeveloped timberlands that are surrounded by residential developments and public roadways. The NWI maps depicts the area as partially ditched/draind freshwater wetlands and the Horry County Soil Survey depicts the soil types of Lynn Haven and Leon (both listed on the National Hydric Soil List). Site photos provided by S&ME depict a non-hydric soil profile of more than 30% uncoated sand grains as well as 2 storm water ponds and a upland excavated non-jurisdictional ditch all void of water. A review of the submitted data sheet reveals that all of the parameters that define a wetland outlined in the Corps 1987 Wetland Delineation Manual are not present; specifically, Hydrology and hydric soil. Based on review of the submitted information by S&ME, and available desktop resources, the Corps has determined that the site is void of any aquatic resources and therefore consists entirely of uplands.
