C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

A review of available office materials indicates that perennial flow documented in the administrative records during previous site visits remain on site and are described as the following: stream geomorphic indicators of perennial flow were channel within bed and banks, had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel of leaves being continuously washed downstream and water flowing after 48 hours from a rainfall event. In addition, other hydrologic indicators observed within the relevant reach of the stream were an even distribution of substrates (longitudinally) in the stream channel, evidence of groundwater discharge (Iron Oxidizing Bacteria) and flowing algae. In addition, during the previous site inspections other resources were reviewed which included Topographic maps, aerial photos, Horry County Soil Survey and Horry County Drainage Study of 1975. Topographic maps depict a symbol which represents a tributary with perennial flow; aerial photos depict a signature of a drainage feature; Horry County Soil Survey depicts a symbol which represents a tributary with perennial flow and the Horry County Drainage Study of 1975 depicts the tributary as a main drainage canal (M-9) that supports a flow regime of perennial.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Jurisdictional limits onsite established by the OWHM of a jurisdictional tributary. The tributary, considered man-made, was determined to be a jurisdictional tributary with perennial flow. During previous site visits documented in the administrative record, were performed under normal climatic conditions. Water was observed flowing within the onsite tributary at the time of site visit. Hydrologic indicators observed onsite were; a well defined channel clear of terrestrial vegetation and debris; even distribution of substrates (longitudinally); deposition bars; litter and debris washed on the banks of tributary. Limits of jurisdiction for tributary was established by a well defined OHWM. Flow of tributary is to Socastee Swamp which discharges into the AIWW. The nearest TNW is the point where Socastee Swamp is tidally influenced just before discharging into the AIWW.

In addition, the project area contains potential wetland areas mapped as the soil type Lynn Haven, a hydric soil listed on the National Hydric Soils list and areas mapped as freshwater forested/shrub wetlands on the Horry NWI Map. During previous site visits documented in the administrative record, wetland areas within the review area consisted of hydrophytic vegetation, however lacked hydrology and/or indicators of hydrology and indicators of a hydric soil. A review of available office resources indicate that current site conditions are similar in nature to those documented in an approved jurisdictional determinations issued in 2006 and a preliminary one issued in 2016.
