and does not have any hydrological connection to any other aquatic resources. There were no drainage structures observed. The Corps investigated downhill from the pond and found no evidence of relatively permanent flow or wetland characteristics. The pond is located on Madison soil (non-hydric). The pond shows up on the USGS topography map along with a dashed blue line. The NWI map also shows the pond (PUBHh) connected to a riverine system (R4SBC and R5SBC). No evidence during the field visit supported the USGS dashed blue line or the NWI R4SBC/R5SBC connection to the upland pond. Based on submitted, available, and collected information, including aerial imagery and an on-site visit on April 12, 2017, this feature is non-jurisdictional and is not a water of the United States.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
