to be non-jurisdictional. The topographic map depicts these waters as forested uplands with no blue lines or other potential linear features depicted nearby. The aerials depict these wetlands as forested and the impoundments are depicted as an open water body. The NWIs depict the isolated wetlands as palustrine forested wetlands (PFO4Bd) and the impoundments as palustrine emergent (PEM1F). The soil survey maps Isolated Wetland "C" as Coxville, which is a hydric soil. The remainder of the site is mapped Lakeland, which is non-hydric. These waters were viewed during the site visit and determined to be completely surrounded by uplands. Isolated Wetland "C" continues south off of the project boundary; however, the southern end of this wetland was also viewed and was determined to be surrounded by uplands. No linear features are depicted within this project boundary and no potentially jurisdictional linear features were observed within the project boundary during the site visit. Because these waters are surrounded by uplands, no surface or shallow subsurface connections from these waters to any Waters of the US (WOUS) were viewed during the site visit.

These four depressional wetlands exhibited hydric soils, hydrophytic vegetation, and indicators of hydrology, which satisfied the criteria set forth in the 1987 Wetland Delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement. The Non-jurisdictional Impoundment A was determined to have been excavated out of Isolated Wetland A. All water located within or draining toward these waters had no discernible or traceable outfall or connection to any WOUS. Additionally, these waters were found to be completely surrounded by forested uplands which further disrupts possible connections to any WOUS. Chemically, these waters do not affect any WOUS in the absorption/treatment of nutrients, runoff, or pollutants. Physically, the topographic location of these waters is such that water in each isolated water is retained and eventually percolates through the soil to groundwater only, at an unknown depth, providing little if any stormwater attenuation. Biologically, these waters are not essential in providing organic carbon in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. Because of the lack of discernible outfall, topography grades and lack of evidence of chemical, physical, or biological connection, these five waters were determined to be isolated, non-jurisdictional.

analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Five isolated waters, totaling approximately 7.63 acres, were assessed within the review area and determined to be non-jurisdictional. The topographic map depicts these waters as forested uplands with no blue lines or other potential linear features depicted nearby. The aeriels depict these wetlands as forested and the impoundments are depicted as an open water body. The NWIs depict the isolated wetlands as palustrine forested wetlands (PFO4Bd) and the impoundments as palustrine emergent (PEM1F). The soil survey maps Isolated Wetland "C" as Coxville, which is a hydric soil. The remainder of the site is mapped Lakeland, which is non-hydric. These waters were viewed during the site visit and determined to be completely surrounded by uplands. Isolated Wetland "C" continues south off of the project boundary; however, the southern end of this wetland was also viewed and was determined to be surrounded by uplands. No linear features are depicted within this project boundary and no potentially jurisdictional linear features were observed within the project boundary during the site visit. Because these waters are surrounded by uplands, no surface or shallow subsurface connections from these waters to any Waters of the US (WOUS) were viewed during the site visit. .
