Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. 

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the Rapanos Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 2.37 acres located in Conway, SC. The site contained potential wetland areas mapped as ditched/drained wetlands (PFO1Bd); however, these areas lacked the three parameters which define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual. Data forms submitted by Southern Palmetto Environmental show the parameters specifically not present were hydrology and the hydric soil parameters. Also present on site is an upland dug ditch determined to drain only uplands. USGS topographic survey information depicts a forested area that is void of blue line features and wetland symbols. Soil survey information depicts the project area as the partially hydric soil Echaw and the hydric soil Lynn Haven. NWI maps outline the project area as uplands (U11, U14) and partially ditched/drained wetlands (PFO1Bd). Based on a combination of the above listed resources the project area was determined to be void of aquatic resources.
