C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site contains one upland excavated non-jurisdictional ditch that does not provide a hydrologic connection between the wetland on site and downstream WOUS. The site also includes 0.02 acres of an isolated non-jurisdictional wetland. . The wetland is surrounded on all sides by uplands that disrupt any hydrologic connection between the wetland and any other WOUS. The entire perimeter of the wetland was observed in the field during a site visit conducted on March 31, 2011.

The site was predominantly developed with a small vegetated depression located in the southwest corner. This depression was bordered to the south and east by vegetated upland berms and to the north and west by a paved developed lot. The depression was sparsely vegetated in the center and transitioned into obligated sedges toward the edges. As you moved up the slopes upland and fac herbaceous vegetation and saplings were dominant. On the top of the slopes predominantly upland herbaceous species were present and fac trees and saplings were observed. Soils within the depressional area were saturated sandy soils and a water table was observed at 13". A layer of muck was observed at the soil surface and sand grains were 100% coated. Two pipes were observed that appeared to carry water into the wetland area. One carrying water from the ASL parking lot and the other carrying water from a residential area to the east. No outfall pipes were located. A shallow ditch, with no indicators of flow, was located behind the upland berm to the east of the depression. This berm is approximately 6' high with no breaks and it did not appear that water could leave the depressional area and enter the ditch. The berm located along the southern property line was approximately 6' high and 8-10' wide. A soil sample taken at the top of the berm revealed soils with greater than 30% uncoated sand grains and high chroma and value. Soils at this location were dry. There was no evidence of overflow from the depressional area on-site over the berm (i.e. no drainage patters, bent vegetation).

The depressional area onsite was determined to meet the three parameters for the identification of a wetland as outlined in the 87 manual however it appears that water that enters the wetland is confined within the wetland and leaves only through evaporation or percolation to an unknown depth. No hydrologic connection was observed between the on-site wetland and any other WOUS. Additionally the wetland was surrounded on all sides by soils that do not meet any hydric soils criteria outlined in the NRCS Field indicators of Hydric Soils Guide.

In addition, a review of the Corps' ORM data base revealed that this wetland was originally part of a larger wetland that was determined to be isolated in a JD issued in 1990 (P/N 26-90-216). Grading and filling of this wetland was authorized under NWP 26 which was verified on June 18, 1990. .
