Wetland 1 is contiguous with and flows into Jurisdictional Ditch 4 which becomes TNW Tidal Ditch.

Wetland 2 flows during high water events into Jurisdictional Ditch 1 which is approximately 20’ away and flows into TNW Critical Marsh (marshes of the Stono River).

Wetland 3 flows through an erosional feature into Wetland 2 during high water events. Wetland 2 ultimately flows into Jurisdictional Ditch 1 which is approximately 20’ away and flows into the marshes of the Stono River.

Wetland 4 flows into Wetland 11 during high water events via an erosional feature in the dirt road that separates the two wetlands. Wetland 11 is contiguous with and flows into Jurisdictional Ditch 4 which becomes TNW Tidal Ditch.

Wetland 11 is contiguous with and flows into Jurisdictional Ditch 4 which becomes TNW Tidal Ditch.

Wetland 5 is a freshwater fringe wetland that is contiguous with TNW Critical Marsh (marshes of the Stono River).

Wetland 7 flows into Wetland 5 during high water events which is approximately 75’ away. Wetland 5 is a freshwater fringe wetland that is contiguous with TNW Critical Marsh (marshes of the Stono River). Wetland 7 is also less than 250’ from the TNW.

Wetlands 8, 9, and 10 are located on the island within the TNW Critical Marsh (marshes of the Stono River) and are fringe wetlands contiguous with the TNW Critical Marsh (marshes of the Stono River).

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must

consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

TNW Critical Marsh /Marshes of the Stono River and TNW Tidal Ditch are part of the Stono River system which is subject to the ebb and flood of the tides and therefore subject to regulation under Section 10 of the River and Harbors Act. Wetlands 1, 2, 3, 4, 5, 7, 8, 9, 10, and 11 have been determined to be adjacent to the Stono River (TNW) and therefore are subject to regulation under Section 404 of the Clean Water Act. Jurisdictional Ditches 1-4 have been determined connect wetlands to the TNW and have relatively permanent flow and therefore are jurisdictional by definition.
