C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 1.02 acres of jurisdictional wetlands and a 1.1 acres of an impoundment of jurisdictional waters. The impoundment is a 404F exemption pond dug out of wetlands under SAC-72-2001-1918. The wetlands on site directly abut an off-site pRPW of Mills Swamp. USGS topographic survey information depicts a forested area with a solid blue line present. The project area is comprised of the hydric soils Blanton and Lynn Haven. NWI maps map the project area as upland cropland.
