The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A small portion of the site drains to the Tyger River watershed. This watershed is 156,602 acres and occupies the Piedmont region of South Carolina. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The seasonal RPWs located on-site are performing a variety of functions related to the biological, chemical, and physical integrity of the downstream TNW. Tributary 2 and Tributary 3 flow seasonally and both flow directly into a perennial RPW. Tributary 2 has an approximate 60 acre drainage area and Tributary 3 has an approximate 33.6 acre drainage. The biological characteristics include providing breeding grounds for aquatic species and habitat for wildlife in the area. The chemical characteristics include filtering pollutants from runoff associated with the nearby agricultural fields and roads. The physical characteristics include storing water during times of heavy rain and the wetter months to provide flow maintenance and maintain seasonal flow volumes. Based on the collective functions described above and their importance to the biological, chemical, and physical characteristics of the downstream TNW (Broad River), it has been determined that there is a significant nexus between the relevant reach of the tributary to the TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This JD documents the jurisdictional status of 4 relatively permanent tributaries. Two of the tributaries have perennial flow and two have seasonal flow.
