## C. SIGNIFICANT NEXUS DETERMINATION

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). 

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of Jurisdiction were established by the 1987 Delineation Manual. This form addresses a 13.17 acre tract that contains 0.35 acres of jurisdictional freshwater wetlands as identified on data sheets and in site photos submitted by S&ME dated 1/9/2015 and depicted on the survey plat submitted by S&ME, prepared by DDC Engineers, Inc., titled "Map of 13.17 ± Acres of Land / City of North Myrtle Beach, Horry County, South Carolina / Wetland Survey / Prepared For: Springfield Development Company, LLC" and dated February 24, 2015. Horry County soil survey information depicts hydric soils within the project area and the NWIs depict palustrine forest. The project area is located within the Coastal South Carolina Drainage area wherein all storm water discharges into the Atlantic Ocean. This results in a direct hydrological, chemical, and biological connection between the wetland within the project area and the Atlantic Ocean (down stream TNW).
