If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of Jurisdiction of wetlands were established by the 1987 Delineation Manual and by a defined OHWM for the onsite tributary considered a perennial RPW. The 0.73 acres of wetlands located within the project area can be seen on the NWIs and in Horry County soil survey sheets. Based on a site visit conducted on 12/02/2014 an on-site pRPW bisects Wetland B and continues off-site. Wetland B is contiguous and directly abuts the on-site portion of the pRPW. Wetland A continues off-site and directly abuts the downstream/off-site portion of the pRPW, as shown in a sketch prepared by the Corps, titled "SAC 2007-0034404JB; Dogbluff Estates - Lot 6 / Supplemental Sketch, " and dated 3/9/2015. Based on direct observation there are no natural or man- made barriers to obstruct the biological, chemical, and/or physical connections between Wetlands A and B and the pRPW. The RPW was observed on site on December 02, 2014 and determined to have perennial flow. The RPW can also be seen in aerial photographs as a shaded linear feature. This pRPW forms the head waters of Evans Branch, which flows into Brunson Swamp. Brunson Swamp Drains into the Little Pee Dee River. The wetlands onsite have a direct effect on the biological, chemical, and physical properties of the RPW downstream.
