C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site consists of 1.39 acres of tidal salt marsh on the lot depicted as "Marsh Lot" and 17.5 square feet of tidal salt marsh on the lot depicted as "Lot 3" on the survey plat referenced above. All other lots represented on the survey plat consist entirely of uplands. The critical area line was certified by SCDHEC-OCRM on October 29, 2014 (as depicted on the survey plat). No site visit was conducted for the subject property. However, a field inspection was conducted on May 14, 2014 for a drainage project (SAC# 2014-00334-3B) located along Brown Pelican Loop directly adjacent to the subject property. During the site visit for the drainage project, it was observed that the majority of the area along Brown Pelican Loop is high sandy land that directly abuts tidal salt marsh. No tributaries, wetlands, or other waters of the U.S. were observed. Based on a review of the best available information including aerial photographs, topographic maps, soil survey information, and NWI maps, it has been determined that the surveyed jurisdictional boundaries shown on the referenced plat are an accurate representation of jurisdictional areas within the Corps' regulatory authority.
