## C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on a review of the aerials, topographic map, soil survey, NWIs, information submitted by the agent, and information obtained during the site visit, this site was determined to consist entirely of uplands. The aerials depict this site as cleared agricultural land with a forested area located near the northern property corner. The topographic map depicts this site as cleared and forested uplands. The NWIs map this site as uplands (U21), and the soil survey maps this site as having non-hydric soils (Pocalla and Brogdon). A data point submitted by the agent that was taken within the small forested area located near the northern property corner determined that this area does not contain hydrophytic vegetation, hydric soils, or indicators of hydrology. During the site visit, the lowest area on site (the forested area) was viewed and soil samples were taken. This area was determined to have non-hydric soils and no indicators of hydrology. The dominant vegetation on site was predominately FAC-Upland. The remainder of the site consists of dry sandy soils that were farmed as recently as last year. This site was determined to contain no wetlands or other waters of the US and consist entirely of uplands.
