determined to be non-jurisdictional. The ditch was excavated entirely out of uplands and drains only uplands. The ditch carries stormwater runoff for a majority of the adjacent neighborhood. The ditch becomes a perennial RPW once it enters the onsite wetland.

## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This site also consists of 91 linear feet of tributaries (PRPW), a 0.47 acre non-jurisdicational pond, and a non-jurisdictional ditch. Wetlands 1 and 2 directly abut the tidally influenced marsh (the high tide line/Critical Area line is the property boundary). Wetland 3 is separated from Wetland 2 by approximately 10'-12' of uplands and is situated approximately 60' from the high tide line of the onsite TNW. Therefore, Wetland 3 was also determined to be adjacent to the TNW. The onsite perennial RPW flows within the boundaries of Wetland 1 and outfalls directly into the adjacent tidally influenced marsh. The tributary exhibited characteristics of perennial flow to include: flowing water at time of site visit, hard sandy bottom, bed and banks, and defined OHWM. A 0.47 acre excavated pond was observed while onsite. The pond was excavated entirely out of uplands and determined to be non-jurisdictional. A ditch along the eastern property boundary was also observed in the field and determined to be non-jurisdictional. The ditch was excavated entirely out of uplands and drains only uplands. The ditch carries stormwater runoff for a majority of the adjacent neighborhood. The ditch becomes a perennial RPW once it enters the onsite wetland.
