**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 357.97 acres of which 213.88 have been determined to be jurisdictional freshwater wetlands adjacent to an offsite tributary (Scoastee Creek) which flows directly to the AIWW. Two previous Jurisdictional Determinations have been performed for the project site: SAC 2007-02688-3H dated 10/22/08 and 81-98-0866 which encompassed a large portions of the Carolina Forest area. Wetland lines remain the same as previously delineated. The site is surrounded to the south and west with residential development. To the north and east undeveloped areas remain. A site visit was performed.**
