This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

According to the agent, this tributary has perennial indicators such as bed and banks, sinuosity, and aquatic macro-invertebrates. This tributary flows north into an unnamed tributary of Big Swamp. Big Swamp, a pRPW, continues south where it flows into the Lynches River, a TNW.

The on-site wetland was determined to be a portion of a larger wetland system that directly abuts the on-site perennial RPW. The aerials and topographic map depict this wetland as continuing west and north off site. The soil survey maps this on-site wetland as Wehadkee and Johnston, a hydric soil, and the NWIs map this wetland as palustrine forested wetlands (PFO1Bd)

Several potentially jurisdictional linear features were observed within the project boundary. These features were determined to be man-made and excavated along agricultural fields. Since the features were determined to be excavated out of uplands and draining only uplands, they were determined to be non-jurisdictional ditches.
