These drainages have no OHWM or signs of relatively permanent flow and only convey stormwater from adjacent uplands. There is also a non-jurisdictional drainage leaving the wetland. This drainage spreads out into overland sheet flow towards the off-site railroad. There is no drainage adjacent to the railroad and no clear drainage path. There are no signs of jurisdictional drainage features, shallow subsurface flow or overland flow off-site or to other waters on-site. The isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetlands and waters of the U.S. This office has determined that the wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The 0.15 acre wetland is directly abutting a seasonal RPW that is located on the eastern portion of the site. The tract is mainly undeveloped, but is surrounded by development. The wetland provides possible breeding grounds for aquatic species and habitat for wildlife in an area that has been disturbed by a lot of development. This wetland also helps to filter pollutants and nutrients from the adjacent development before they flow to the downstream TNW. The wetland helps to perform flow maintenance by storing flood waters during times of heavy rain and during the wetter months.**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the downstream TNW, it has been determined that there is a significant nexus between the relevant reach of the tributary and its adjacent wetlands to the downstream TNW.
