Non-Jurisdictional Linear Conveyance A is on the southern property boundary and then turns north and runs to the River. This feature is a non-jurisdictional linear conveyance feature approximately 2255 ft. in length and 12 ft. in width.

Non-Jurisdictional Linear Conveyance B runs from within the property to its intersection with linear conveyance A. This feature is approximately 630 ft. in length and 6 ft. in width.

These nine linear features were determined to be non-jurisdictional as they were excavated wholly from uplands and do not contain an ordinary high water mark. They do not contain any water and appear to have been constructed to convey stormwater from the existing industrial site. They only carry water only during significant rain events.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
