C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The area that the wetland traverses to get to Big Swamp is mapped as Bladen soil on the NRCS Soil Survey. This soil type is hydric. This same area is also mapped as palustrine wetlands on the National Wetlands Inventory (NWI) map.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 1.75 acres in Myrtle Beach, SC. A site visit was conducted on January 26, 2018. Approximately 0.83 acres are wetlands directly abutting Big Swamp (perennial RPW upstream and becomes a TNW downstream). There was standing water throughout the wetland during the site visit. The soils observed onsite were a sandy loam that met the F3 Hydric Soils indicator. Topo maps depict a solid blue line bordering the north of the project boundary. NWI maps map the project area as forested wetlands (PFO1/4B)
