These excluded waters do not abut and are not inundated by an (a)(1)-(3) water. Additionally, these excluded waters are physically separated from any (a)(1)-(3) waters by multiple physical, man-made barriers (residential lots, roads, etc.) and uplands. The excluded waters are surrounded by uplands (review of NWI, Topographic Maps, aerial, and soils maps). Additionally, the USGS TNM-National Hydrology Dataset updated July 2020, depicts no flow of the wetlands outside the man-made barriers to include subdivisions, and public access roads that surround the entire wetland system, both onsite and offsite. The entire wetland system of

Excluded Waters #1 is surrounded by the following public roads: Petigru Road, Waverley Mills Road and Martin Luther King Road. The applicant on March 17, 2021, provided supplemental site photos that depict no flow/culvert under Waverly Road located to the south of the review area and upland development to the north where culverts have been installed under a residential development and road to handle stormwater flow. At these two locations described above, the wetland system of Excluded Waters #1 is separated from jurisdictional waters by multiple man-made barriers. A site visit was performed for this Jurisdictional Determination.
